 1. The foreigner's mobile number is required and cannot be the same as the phone number of the employer. If the phone number is not provided, the application will be returned for revision; the email section must be checked "Yes" or "No", or else the application will be returned for revision. If you tick "Yes", please enter the email address and it must not be the same as the email of the employer.

 3. Extension of transfer period:
Foreigners may apply for one-time extension of transfer period 14 days prior to the expiration day of the transfer period. One who is the victim of criminal proceedings can apply for multiple times of extension, yet the extension will not exceed day the prosecutor authority made the non-prosecution decision or the day of the first-instance judgement.

10. Foreigner's passport numbers are required. If the foreigners are not employed in Taiwan for the first time and have renewed the passport number, they have to immediately apply to the Immigration Agency of the Ministry of the Interior for the update of their information.
